Lauren Brice: I haven't.

Will Menzies: As a non-indigenous person it makes me uncomfortable that a lot of non-indigenous people will be voting on the indigenous officer. I'd like to point out that it is not ideal; but I don't have a solution to the problem.

Roxanna Henshaw: I would like the previous statement noted.

Grace Hill: I know both of these people – one more than the other. But I know both would do a very good job as indigenous officer.

Caleb Pattinson: Seeing as Latoya will be going into the role next year – this could be launching platform for her, or a short role for Tyme, allowing for differing ideas and more fresh ideas.

Roxanna Henshaw: Tyme – seemed to put more effort not application. Though that may not really be a substantial reason to accept a candidate

Motion: Student Council appoints Tyme as the Indigenous Officer.

6.5 Student Council Induction:

Chris O'Grady: One of the tasks Jonathon is working on is SC induction for next year. Hopefully you've had a chance to look at the proposal Jonathon has put together and has been made in conjunction with a meeting with Grace Hill and Roxanna Henshaw and what other SC's do around the year

Jonathon Louth: Took some time to look at institutions around the country and use some of my experience from the UK. I have shifted it from an on-campus delivery to an away-day. Jonathon Louth: There was talk at one stage of having a camp or retreat. Not popular for many people as it takes away from their family, home or children. In many instances it does reflect the induction processes which are already in place however there's additional time for planning and talking.

Chris O'Grady: Given that this is the current student council – but if you have any ideas of what you think would be ideal or what should be included for next year's Student Council we'd love to hear from you. Please let myself or Jonathon know.

Jonathon: That's the other thing – we've shifted it to November as well because either the incoming or outgoing council were away. The first day is both the incoming and outgoing council and the second day is exclusively the incoming

Tim Mitchell: I was just going to say, obviously on the first day both the current and the incoming Council will be involved. Is it entirely necessary for the current council to come to any of the sessions other than lunch?

Jonathon Louth: No, but you're welcome to come for just that session or stay.

Grace Hill: I just want to note that at the beginning of this motion saying that it's put together in consultation is not that I endorse this plan. The consultation involved me being quite critical of this plan.

Grace Hill: I agree that it needs to be held some time that everybody is not on holiday. I disagree with spending thousands of dollars on an off-campus induction event. I think there's no reason why we can't have something on campus rather than spending thousands of dollars to shift people off campus

Will Menzies: I would note that it's important for SC to work together and this seems like a really good idea to help with that. I would like to add that OBs have budgets to go off to conferences for self-development and building their role. I don't see a difference between this and that except that with this it is for everyone.

Alison Taylor: I would hate to know what it would feel like as an OB walking into a role without knowing it. The thing is that we can look back on this and re-evaluate. But we do need to have this induction because they need to know what they're walking into

Grace Hill: I don't think anyone's arguing against having an induction. I would hope that we agree that it's important. However, what I am objecting to is what I would see as a bit of an egregious waste of money. Conferences are held interstate. This is not something where it's set by an external body – this is us taking a day trip at the cost of venue hire. Which I think is kind of outrageous

Michael Bezuidenhout: I'm not an expert on this kind of stuff. I'm not particularly... In the context of FUSA this is only a small amount. Is this funded by SSAF?

Jonathon Louth: I have submitted a proposal to VC for funding seeing as it is a meet and greet with staff.

Michael Bezuidenhout: I don't see it as the gravy train or anything about that. I'm willing to trust Jonathon has got the right stuff in it?

Jaka Yusuf: Should be focused on how each council member can work with each other. Because I experienced that when I started this council that I didn't have the induction properly and it's a bit difficult for me to catch-up. Secondly, I think that there should be consideration that all SC should have this induction. If any Student Council member cannot make it, that person should get another proper induction at another time. International students go back to their home in January. So it is a great idea to have it in November Will Menzies: Venue hire is 360, catering is 1,000?

Jonathon Louth: Yes. About \$20 per meal, about \$40 per person

Will Menzies: Could we get just purchase food and bring it along - \$1000 for a day seems a bit excessive.

Jonathon Louth: In terms of catering in the city – the figure is about right. But we could look at ways of reducing it further

Ira Herbold: I just wanted to clarify. Re: catering. If we were to do it on campus we would save the venue hire. Would we still be providing the breakfast and dinner as well? Jonathon Louth: It would depend on whether you as council would decide that or not. I was trying to create a 2 day opportunity where you would not be distracted by university activities. Costs could certainly be reduced if you held it on campus.

Chris O'Grady: All of the catering areas around refectory may be shut down on that time John Photakis: I was just going to echo what Chris said – when exams finish they will be digging up the plaza

Michael Bezuidenhout: If people are so keen to cut costs in terms of venue hire and catering – if we want people to come and actually go then making it a budget event like last time probably wont improve numbers. It's probably a worthwhile cost to get a decently trained student council.

Grace Hill: Move to go to a vote.

Motion: That Student Council approve the below budget to come from 'Student Council – Professional Development' (\$5,000) with the option for the Manager, Student Engagement to make minor changes if required.

Chris O'Grady: Any club can become financially affiliated

Tut Tut: Just as an addition – if what he said is going to be implemented maybe we should also implement a caveat that may prevent students from joining who might have nefarious intentions. Students may try and infiltrate other clubs, just general skulduggery, and we don't want that.

6.8 DVD rentals

Chris O'Grady: Shaun and Paul have put together some information, some background info on the DVD service – essentially we inherited this from F1. There are some stats on the document of the rentals and unique members. DVD rentals have halved every year recently. It is very timely to bring this up as an issue as FUSA will be moving in the next few weeks and it would be timely to know what Student Council would like to do with this service. To keep it running we would need to purchase new DVDs. With downloads on the rise it's not as sustainable as it was previously. We can continue on or abandon all together (have a sell-off). Caleb Pattinson: I support the motion to abolish this because DVD stores are dead and dying off. I would suggest abolishing it.

Michael Bezuidenhout: clearly the use of DVDs is in decline – I don't think it would be useful to have it continue with only 33 people using it. I wouldn't be super opposed to selling them all. I think we should give it a go that we make it free and put posters around so that we can get students some use of it before we sell them off or something. So perhaps maybe it'd be useful trialling them for free with advertising it. And maybe once the numbers dropped down again we should abandon them at that point.

Chris O'Grady: Just so everyone is aware it is currently \$1 per DVD

Tim Mitchell: It's obviously a drag on admin staff who could be better using their time than doing the DVD rentals. I would be in 100% support of abandoning the DVDs.

Chris O'Grady: We can donate the educational ones that are of use to the library.

Tut Tut: Propose a move to the vote because the economics is pretty self-explanatory.

Grace Hill: There currently is no motion, would you like to motion to abandon them?

Tut Tut: Yes, I am for complete abandonment; we sell them or give them away

Caleb Pattinson: Propose the possibility to donate or sell these off to flics – the film society.

They might be willing to continue the hire for free or for a dollar?

Grace Hill: Move to abolish this – we could decide at a later date

Michael Bezuidenhout: I feel like we should not motion to move to abolish before we've decided what to do with them

Chris O'Grady: It doesn't have to be today – could be done next month

Motion: To postpone the decision until next meeting.

Moved: Michael Bezuidenhout Seconded: Grace Hill

6.9 SSAF Expenditure

Grace Hill: Chris and I meet with DVCA – proposal to have 250k of SSAF funds of next year to be spent on the construction on the hub. Basically I would argue that the spirit of SSAF is about student services, student representation and student life. Not about the university's major property development. SSAF is for student control of student affairs – not building projects especially not when it would be at the expense of student services.

Will Menzies: Firstly, I agree with everything grace just said. I think it's really inappropriate that SSAF funds are used on the hub which are not just student services – they should not be spent on the flinders university council board meeting room. I would also say that it's inappropriate that we have been informed about this so late in the picture. We have not had time to consult with the students. This is way too late in the game to be hearing about this now. Finally, this figure of \$250,000 seems really arbitrary and I would like to know what they would like to do that

Grace Hill: I agree it is quite late and it's sort of a situation of last minute budget hole. The SSAF advisory committee is sending this to the VC to send this to students for review. There hasn't been anything specific with it – just 250k as just a sum of money. It does seem fairly arbitrary.

Moved: Grace Hill Seconded: Yaddollah Bahrami

7.1 Racism on Campus

Grace Hill: Speaking on behalf of James who cannot be here today. Islamaphobia which is rife through Australian media and politics. It's important that it be noted here that this has manifested in some pretty extreme racism against Muslims on campus. Everything from people being called "terrorist bitches", people being made fun of for not speaking English, people come up and trying to rip off their hijab's. This is, obviously, absolutely despicable. But it has not just come out of nowhere by coincidence at the same time as this anti-Muslim hysteria in Australia. This is a reflection of what is happening nationally.

Will Menzies: Somebody has attempted to rip off somebody's hijab on campus? Grace Hill: That was a flinders student nearby campus – though the rest of the incidents have happened on campus. The rest of the issues have happened on campus.

Chris O'Grady: We have a Student Equal Opportunity Advisor, Anne Hayes, you can advise students to report these incidents or any incidents they see.

7.2 Student activists repeatedly harassing disabled students in areas of high traffic.

Jaka Yusuf: An email came to me this morning and asked whether this item could be added as a matter for discussion. What has actually happened is that a concerned student has described how she felt by several activists and people who were campaigning in the recent Student Council elections. I am going to meet her on Friday to get an account of what happened and will bring it to the next meeting if necessary. As for the meeting on Friday morning – I would like to propose one of the council members to assist me on meeting this woman because I don't want just a one on one meeting with her – I'm planning to meet her in one of the study rooms in the library.

Rosalie Dow: I thought that maybe clubs could purchase the dvds for like \$2 and fusa members could purchase them for \$5 so that we could have a bit of a boost for clubs. We might also get rid of more of them if they're available for students

Will Menzies: I'm amenable

Tim Mitchell: I was going to say \$5 for students and clubs

Michael Bezuidenhout: I'm slightly concerned because the majority of them wont be sold for \$5. I have issues in terms of selling them all or giving them away which will sort of concentrate them to certain students even though they were bought with collective funds of all students.

Michael Bezuidenhout: They can go away in storage now and come back in the new hub and we should at least try a couple of months of free hire so that all students get a chance at using them.

Grace Hill: It looks like we're going to be getting rid of them.

Grace Hill: There's been two proposals so far that they're available for \$5 or at a lesser amount of clubs.

Michael Bezuidenhout: I raise the point that students have already paid for these dvds and now we want them to pay for it again.

John Photakis: It sounds like it might be too expensive.

Caleb Pattinson: We talked about last meeting about approaching one of the clubs. But I had another idea, I'd like to approach a club and perhaps they could do it \$1 / dvd and keep the money. If the students know where the money is going they might be more willing to hire a dvd.

Tim Mitchell: I suppose the only problem I'd have with that would be the administrative cost or the task of renting them out or who would have the space

Rosalie Dow: Apart from Womens and Queers collectives no one has their own actual space on campus

Will Menzies: I don't mind the idea, I don't think any clubs would want to take that responsibility on, but we could put it out there for a month.

Roxanna Henshaw: Did we amend your motion to \$2 for clubs and \$5 per person?

Will Menzies: Not yet.

Michael Bezuidenhout: I think we can delegate pricing to FUSA staff or whoever's doing it at the time

Tim Mitchell: When you say clubs, is this going to just be FLICS? Or is this all affiliated clubs?

Will Menzies: I don't think we should be burdening FUSA with selling DVDs on top of all other o'week stuff.

I think it's better to get rid of the stuff so that FUSA doesn't have to be dealing with it next year.

Jaka has entered the room 6:21pm

Rosalie Dow: Would flinders living have a communal space they would like to have them?

Will Menzies: I'm not really amenable to just donating all of them. But someone else is fine to

Rosalie Dow: I move that FUSA approaches the University hall about donating the DVDs to them.

Michael Bezuidenhout: Also, would you be okay with adding to the motion that if Uni Hall don't want them that we donate them to the library.

7.18 Endorsement of Flinders University's joint hosting of Fairly Educated 2015

Will Menzies: It's an annual conference which has been going for about 5 or so years now. There's a bunch of students from Adelaide and Flinders who have put an application to host it as SA. This would be a join hosting by flinders and Adelaide. Adelaide is already fair trade accredited and flinders is on the way. It would be a really great way to give an opportunity for the thousand students who have signed the fair trade petition to engage. FUSA won't have to organize it and won't be responsible for organizing. But it would be great for FUSA to support it as it will involve a number of FUSA clubs.

Roxanna Henshaw: Will they be looking at us to donate any money?

Will Menzies: There may be money, but that will be the responsibility of the organisers themselves, this is not FUSA signing a blank check.

James Vigus: What is the nature of this conference? Is it something that's organized by a specific group? Or is it a student conference organized by something like the national union of students? As far as I can see it's not quite the same as something like QC or EdCon.

Will Menzies: Bit of background. Fairly educated was started by students from Sydney university who had been running a fair trade campaign there for a number of years. They had a student population referendum which approved switching to fair trade but the university did not change their policy. So they thought they would create a forum to facilitate students to be able to fight against that. So it's not from a corporate background, it's from a student background. It's not a student union thing, it's a broader student population thing. This is one of the best examples in Australia of a student lead movement that has got some really great results around the country. In terms of budget, this would be coming out of my budget, the Environment Officer's budget.

Grace Hill: My concern just stems from an unknown quantity of money being committed to an event that FUSA doesn't really have a say in next year by this current group of people (this years council members). Just to clarify, the money you're proposing is coming from this year's Environment Officer's budget. How much is it?

Will Menzies: I don't have the exact numbers, but it will be whatever is left in the budget on December 1st 2014.

Michael Bezuidenhout: I sort of recognize that as it's coming out of the Environment Officer's budget I think you can be fairly autonomous as to how that's spent, but we should have a bit more knowledge about the budget is being spent. In principle, I generally agree with it.

Will Menzies: To address that, we had the sustain-a-fair last week – so I wasn't sure of the exact amount left in the budget which is why it's not there.

Caleb Pattinson: I have a question, if Will doesn't spend his budget this year, what happens to the funds?

Chris O'Grady: It just gets sucked back into the university

Chris O'Grady: The SSAF budget has already been established for next year. So probably the best thing to do would probably be to wait and having the environment officer next year apply for extra funds. It is SSAF funds, so a consideration has to be given to how much is going to Flinders University students. I'm wondering also how it fits into the categories of SSAF expenditure.

Chris O'Grady: It's a possibility but I can't give a definitive answer.

Grace Hill: It doesn't sound like we can use the funds from this year.

Will Menzies: I think if we could move forward with the presumption that this is possible and vote for it on that basis.

Roxanna Henshaw: Do you want to post-pone it to the next meeting?

Will Menzies: I would rather not, because last year the last meeting didn't actually happen

James Vigus: If we pass the motion, fine, but obviously if we can't use the money you don't need to change the motion because it just can't happen.

7. Matters for Discussion:

7.1 FUSA Income Stream - Chris O'Grady

Caleb Pattinson: I love the idea, this might be thinking too big, but I recently heard that the new hub's going to have a few venues for lease. If we could somehow have the startup money I'd love to see FUSA have a food outlet.

Tim Mitchell: A potential option would be income from vending machines which are already around the university.

Roxanna Henshaw: Could they be fair trade vending machines?

Chris O'Grady: Shane mentioned in the meeting that he's not amenable to the Student Association establishing a food outlet on campus.

Rosalie Dow: But why? Plenty of universities have student association/student union food outlets.

Will Menzies: I think that we should note in the context of this discussion that Shane McGregor is also on the board of FlindersOne.

Michael Bezuidenhout: I think I'd be fairly pro-vending machines. I also take slight issue of not even being able to discuss the option of a food outlet. I think it's important for students to have access to have low price student run outlets. There's not a lot we can do in face of the University's opposition to this.

Alison Taylor: We shouldn't just go "he said we can't have this lets just back down". The food vans are great, but they're to expensive. The FlindersOne cafes don't provide a lot of options for students.

Caleb Pattinson: I actually had this idea some months ago, I think with the food vans we should be charging maybe \$20 bucks a day or something.

Will Menzies: Last year, student council had a discussion about pricing which I don't think we really followed up on this year. So I definitely think that's a good thing for student council to be looking at. I also think we should acknowledge that FlindersOne has improved their services over the last year.

Alison Taylor: I don't know the specific contract with FlindersOne and the vending machines. If we bought vending machines, would be able to get them on campus or would we have to get the FlindersOne contract?

Chris O'Grady: I think Shane McGregor would be able to determine that.

John Photakis: I just want to bring the council up to date – FlindersOne has tried to make changes to more options but just one of my friends who is gluten intolerant has had a lot of trouble finding gluten-free options on campus.

Will Menzies: I think that it's important that us as a student association that as much of the money that is spent on campus is staying on campus. So when it comes to food and

beverage contracts on campus I think it's really important that the contracts should stay with us or FlindersOne so that money remains on campus.

Rosalie Dow: Vending machines wouldn't necessarily be the best options for students because they're often unhealthy food at high prices. I think we should look at food providing options regardless of what flinders has to say about it.

Michael Bezuidenhout: Perhaps, we should have a motion next meeting suggesting more gluten free options in FlindersOne outlets

Ira Herbold: Maybe it would be a good thing to allow student council members to participate in a group to further discuss this and discuss options.

7.2 Budget for indigenous students fund

Tyme Childs: Id' like to put a call out to all indigenous students and reach out and make contact with all those students and get something happening and maybe put out a questionnaire as to maybe why they're not reaching out and getting involved with groups on campus.

Grace Hill: After the meeting we can work out how much you have left. It's your prerogative on how to spend it and next meeting you'd just need to submit a motion with the amount and how you're going to spend it.

6.10 Accessibility Officer's Report

November 2014

- 1. Student Council monthly meeting
- I. Attending the Student Council monthly meeting on Tuesday, October $7^{\rm th}$, 2014
- 2. Adaptive Technology room
- II. An adaptive technology room is a room full of assistive devices to support student with various disabilities. The room is available for those who have disability access plan at anytime, following the opening hours of the central library. During the exam periods, the room is not available, unless the student is scheduled for an exam with in the room. Ability officer communicate with disability concelors regarding two things:
 - 1. During the exam period, one of the computer equipted with dragon text to speech, screen reader and a magnifier device is relocated somewhere else in the library. Therefore, other students with disabilities could still use the computer for other purposes.
 - 2. Adaptive technology room should also be in Sturt and Victoria Campuss, so students with disabilities who are more often in those campuses could benefit.
- 3. A student with disabilities is hospitalized
- III. A student with disabilities had a surgery and it went well. However, after the surgery, he was failed to breathe and require CPR. Unfortunately, the action taken cause complication to this internal organ and put him in critical condition. Ability officer visited him and his wife to ensure he could get full access of the insurance scheme. Ability officer also monitor his health progress. The student is an AAS scholar and with in his contract is written if awardee is hospitalized with in 6 weeks, then AUSAID will stop his stipend temporary, until the awardee is discharge. Ability officer discuss this with the wife, so she is aware of it, and will monitor the progress or come up with alternative if the student has to be in the hospital for that long.

6.11 Post Graduate Officer's report

Government Higher Education Reform Bill.

FUSA Staff

Office Coordinator

The Office Coordinator vacancy (continuing position) has closed and interviews have been conducted. An announcement regarding the new staff member will be made in the coming weeks

Shaun Hobby

It was with sadness that on the 24th of December, we will farewell our current Office Coordinator, Shaun Hobby who has been with us since early 2013 and has done a stellar job as both Administrative Assistant and then Office Coordinator. I would like to thank Shaun for his ideas, creativity and thinking outside of the square when it came to supporting the student representatives and staff in their work.

2015 FUSA/Office of Student Engagement Budget

The SSAF Budget Advisory Committee met to discuss student feedback on the draft 2015 SSAF Budget. The budget was only changed slightly to allow an increase in funds to the Health and Counselling and Disability service. The Vice-Chancellor has formally approved the budget.

Movement of FUSA

During the Hub build, FUSA will move to Level 4 Engineering and this will occur in midlate January 2015. The front door of FUSA will be boarded up on the week beginning the 1st of December and the alternative route by through the 'breezeway' across from the prayer rooms and through the old OASIS door.

The Queer Space, Women's Room and Empire Times have all been moved from their spaces in the 'mall'. Empire Times will be temporarily located in Law and Commerce until another home will be found for them for the duration of 2015.

Executive Director (Student and Academic Services)

From 3 November Gerard Toohey began in the new role of Executive Director (Student and Academic Services) and will do so until mid-2016. Gerard will be assuming line-oversight responsibility for the Office of Student Engagement (as well as the Office of Student Recruitment, the Office of Health, Counselling and Disability Services, and the

Office of Student Administration and Systems). This means that I now report directly to Gerard.

Gerard was the Director, Student Services at Monash University before being engaged over the last few months as a consultant to provide advice to Flinders Senior Executive on the model for student service delivery in the future as part of the new 'student hub'.

2015 Student Council Induction

The 2015 Student Induction took place this week. I would like to extend a huge thank you to the 2014 student council representatives that came along to share their expertise and knowledge. This was a huge factor in making this event a success.

Student Radio

Funds have been approved for Student Radio in 2015. Myself and the Media Officer will now embark on a scoping and research exercise which will culminate in a proposal for Student council to consider in 2015.

7.4 FUSA DVD's

As per the last motion at Student Council (November), it was decided that the FUSA DVD service would be wound up and all DVD's donated to Flinders Living. After being approached, the Dean of Flinders Living explained that Flinders living do not have the capacity to oversee and administer a library for a DVD service. They have previously operated a library out of Flinders Living for books but this has recently ceased.

After some discussion, it was suggested that the FUSA DVD's could go to Flinders University Library where all students have access to the DVD's.

I have spoken to the Acting University Librarian who has informed me that if Student Council were so inclined to donate the DVD's to the Library for the enjoyment of all students on campus, that they would happily accept them.

Motion: All FUSA DVDs will be donated to Flinders University Library in January 2015.

7.5 FUSA BALL INCOME

FUSA collected \$9,600 in ticket sales which is sitting in the FUSA NAB Bank account. All expenses have come from SSAF. If FUSA were to reimburse the University for the amount spent on alcohol only (\$6,192.00) as per the agreement to not spend SSAF on alcohol, then this would leave FUSA with a profit of: \$3,408 from the event.

I know that Student Council did not intend on this event to be profitable for FUSA but this is a way to assist FUSA financially. I have approached the DVC(A) regarding the proposal of FUSA keeping some profit from the FUSA Ball and he has approved this if indeed Student Council would like to proceed this way.

Motion: \$3,408 profit from ticket sales form the FUSA Ball remains in the FUSA NAB

Bank account.

7.6 **STUDENT CLUBS RESOURCES** (Prepared by Adam Rau)

The FUSA Clubs and Societies have a significant portion of club grant funding remaining

for the year, and consequently have been contacted to discuss club equipment that

could be shared amongst all clubs and FUSA for future use. The below list is a collation

of requests for the clubs. These purchases would ideally be made before the end of

2014. Consequently, after quotation we expect to spend \$5601.06 on club equipment,

however are requesting \$6,000 to be approved to allow for changes to item costs,

delivery and insurance. There is currently \$10,000 of unspent funds in the 'Clubs

Resources' budget line.

7.7 FUSA Banking and Cash Handling Arrangements for 2014 and Beyond (Prepared by Shaun Hobby)

Background

With the closure of the National Bank branch on August 8 2014, FUSA lost access to its regular banking facilities. This raises not only an issue around the ongoing cash management practices of the Association office, but also an opportunity to investigate increasing the flexibility of our payment processing capacity. Anecdotally, the lack of alternative payment options has generated negative feedback in the lead up to major events on the campus social calendar.

An interim arrangement with the Cashers Office to facilitate the short term storage of banking deposit bags awaiting collection has been developed, but a longer term solution is required.

Event Ticketing

FUSA has a number of functions that involve the sale of items and tickets, and it can be reasonably assumed that this function will grow in the coming years. A number of events have been ticketed throughout this year. The individual price points for the event tickets have ranged in value from relatively low (\$2.00 for the International No Diet Day seminar) to relatively high (\$50.00-\$75.00 for the FUSA 2014 Winter Wonderland Ball). Irrespective of the individual value of the tickets or the number of tickets sold, the security concerns associated with not having a long-term cash management strategy remain.

DVD Rental

FUSA will cease its DVD rental service at the end of 2014. The DVD stocks will be distributed to other groups within the university community for use by their customers

and stakeholders. The end of DVD rental represents the end of an entire section of FUSA's cash-dependent activities.

Employment Listings

The employment listing service has operated in an entirely online environment since the beginning of 2014. The demand for over-the-counter employment listings is negligible. Currently, two out of the five register departments are reserved for the processing of employment listings.

Summary

With the cessation of the DVD rental service, the FUSA office will transition from an operation which processes infrequent small transactions throughout the year to one which has a handful of high volume transactional periods. Cash transaction recepts have dropped across the board during 2014. The smaller-value transactions, such as DVDs and Employment Listings have seen a fall of approximately 60% while there has been a 35% reduction in the value of cash transactions associated with the larger-value events such as the End of Semester Party, Pub Crawls and FUSA Ball. These reductions in total receipts come in the face of increased attendance at the events (for example, two pub crawls were held in 2014, instead of one). The transactions associated with these larger events are of a sufficient value that cash payments are unlikely to be the first option for most customers.

Recommendations

- 1. Investigate the feasibility of replacing the FUSA cash register with an EFTPOS terminal.
- 2. Cease FUSA office cash handling activities and go "cashless".
- 3. Review the requirements for the maintenance of a safe in the FUSA office.

Rationale:

On the 18th of November I cleared out the Queer Space in preparation for the Hub development work that needed to happen. Hopefully the temporary 2015 Queer Space will be ready by about O-Week 2015. During the packing up process, I threw away a lot of old and worn out resources. These included faded posters and out of date educational resources. I would like to replace these and improve the QS resources in general. In consultation with members of the Queer Society, I have developed a list of resources we would like to purchase. It includes queer-themed posters and educational resources including books. It also includes a few decorative items, such as new cushions for the QS couches, to make the space (currently a white box) more inviting, and some games, as currently FUQS members are bringing in their own board and card games for lunch gatherings.

7.9 NUS National Conference Registration - Michael Bezuidenhout

Preamble: Many of the line items in this years FUSA budget not being fully used and we will be unable to utilise any of this years unused allocations next year. In the use it or lose it context we find ourselves in and in the interests of using this money to advance the interests of Flinders Uni students, I propose we utilise some of this unused money for the professional development of those that participate in the FUSA election process in order to better educate those that seek to represent this \$1.6 million organisation on the national stage.

It is easy to notice that candidates who run for NUS Delegate positions often run multiple times and while some may miss out this year it is likely they could be elected next year. NUS Delegates have a lot of power and responsibility in setting the agenda of the national student union movement and it is unwise to send delegates who are unfamiliar and unprepared for the complex NUS system.

As such, I contacted all of this years unsuccessful candidates to see if they did indeed

intend to run again next year and if they would be interested in experiencing NUS National Conference this year in order to develop their platform and skills so they might be able to contribute to a more nuanced NUS debate at the next elections and, if elected, have more knowledge and skills to guide them through representing FUSA on a national stage. Many responded positively but were unfortunately unable to make it for various reasons, however one candidate was available and very interested.

Given only one person is available, it is more than within FUSA's financial position to extend the opportunity for an active and engaged student to attend the NUS National Conference to learn about the institution and develop their skills to better campaign and fight for the values and platform of the Flinders University Student Association and for the interests, rights and welfare of Flinders University students as a whole.

Registration includes accommodation, food and access to the conference. Travel is expected to be paid by the successful student to demonstrate their commitment to this program of professional development.
