3. Welcome Guests: Adam Rau

Adam Rau - Explained his position at FUSA as Clubs and Events Officer.

6.1. FUSA Non- Partisanship – Michael Bezuidenhout

Post-Graduate Officer: Fundamentally disagree with comparing a student association with the institution of parliament is wrong. It's a democratic organisation and its space should respect that. Think that this goes way too far and that people should reject it. In Federal parliament the political parties have whole sections that are dedicated to those parties and electoral

offices are decked out in political party memorabilia. We are a student association and a political space

Michael Bezuidenhout: The comment regarding parliament doesn't actually have an effect on the motion, it was only in the preamble. If student council endorses it the material, it is welcome to be there. We want to engage with students and do not want to scare any away because of the impression we make. FUSA is a political organisation. To be directly partisan would be wrong, for example to say the labor party is FUSA. If a candidate wants to run with a labor party logo, that's fine, go and do it. But when you get in this office I don't think it is right to make it seem that this office is run by a particular group.

Welfare Officer: I have an issue with any attempt to institutionalise a policy which restricts speech or expression. There's a perfectly legitimate concern with the attitudes students will have with political material displayed in the FUSA office. My issue is when you do institutionalize a policy like this you create a threat down the line, grounds to restrict speech in ways which would not be at all reasonable. I appreciate that you have put elements into the motion that attempt to prevent that. But I am very hesitant to institutionalise restrictions.

Tut Tut: It's very ridiculous to think that FUSA, as the student body of the whole Uni, is going to be put up as some kind of political shop-front for a small faction. What we're trying to say here is that we should not run in ignorance of the reality that we have political diversity at University. FUSA should seek to represent the totality of students, not a small far left faction which includes the people who spoke against the motion. We don't seek to censor anyone or shut down the debate, all that we want is equality of speech and to represent all students equally.

Education Office: I feel that we have touched on this issue a fair bit in that FUSA should not be projecting an image of a particular political body I don't think we should be seen to represent a single political organisation.

Michael Bezuidenhout: I don't buy into the slippery slope that may restrict or censor FUSA in the future. This is not an attempt to stifle debate or anything .This is only for FUSA, not anything else at the University. If a party says something good, then it's fine for us to agree to it. It's just for if someone has a problem with something that has already been put up then this is the avenue they can take.

Queer Officer: When you walk into the FUSA office it's quite in your face with the number of political posters there. I think it would be great to have a bit more of a range of posters such as the Step Up posters. IT would be great to have a range of posters on a diverse range of issues.

6.9. <u>Student Council budget Response – Student President</u>

Student President: It's necessary for us to take a very strong stance on this. We should reject the budget and the idea that Australia is in some sort of budget crisis.

Michael Bezuidenhout: Agree with you in terms of condemning the budget. What I would draw exception to is point 3 of the budget. The deregulation of places has nothing to do with the budget. Deregulation of places has allowed more people to access places at University including those from low SES backgrounds. I think it is outrageous that you would condemn that. I don't support the removal of HECS, I don't' think a worker on minimum wage should be subsidising a degree of a doctor who will never have to pay it back. A modest contribution from students is important.

Student President: In terms of deregulation of places, I think it is related to deregulation of fees as it is part of a broader neoliberal agenda of giving the private sector control over universities rather than the public sector. The deregulation of places was not accompanied by an increase of university funding resulting in lower education for university students.

General Secretary: Can you amend it to include Austudy in 4?

Amendment agreed upon.

General Secretary: I would prefer if you were to amend it to remove deregulation of places but keep deregulation of fees

Michael Bezuidenhout: I'm a bit confused because you want more people to come to Uni but want to put restrictions on the amount of people who come to university. Are you for or against more people attending university?

Tut Tut: Firstly, I think the motion betrays a very huge it's more akin to a young kid crying because they can't get what they want. it won't dampen the government's resolve to fix the

Student President: I'm for more people coming to University, but I'm against universities enrolling more people to gain more money without increases in funding to allow students to access quality education. Deregulation has meant a lowering of education for many people.

Education Officer: It's just sort of a minor thing, but it's student council's budget response but then in 3 it calls for a fully government funded system where students can access education. This isn't really a response to the budget, it's more a critique of the entire education system.

Environment Officer: It doesn't seem like you are in favour of that amendment of places so we could just vote it down and someone else can move the amended one

Student President: Happy to amend it, removing "places and adding Austudy but note that I'm really cheesed about it.

Motion:

- 1. The Student Council condemns the Abbott government's 2014 budget, and its attacks on the most vulnerable members of society, while doling out enormous sums of money to corporate Australia.
- 2. The Student Council refutes the claims Australia is in a budget crisis, and recognises that this argument is being used to undermine the most basic of provisions for welfare and social security.
- 3. The Student Council opposes the deregulation of places and fees in the higher education system, and calls for a fully government funded system where every student can access free education.
- 4. The Student Council opposes any moves to convert student welfare into loans, and calls on more government funding to support low-SES students. The Student Council also calls for an increase in the amount of, and accessibility of, Youth Allowance, Newstart and ABSTUDY payments.
- 5. The Student Council opposes the removal of the equity quotas for the higher education system. The Student Council acknowledges that quotas for low-SES students are crucial for the inclusion of students from working class and other disadvantaged backgrounds, who face innumerable obstacles, into higher education.
