7. Matters for Decision

7.1 Online Learning at Flinders – Jesse Stevens

Preamble

Online learning is becoming more popular around the world. It is important that universities, as institutions recognised by both the public and private sector as being reliable and credible providers of education, have a clearly defined role in the increasingly global web of online learning. It is also important that FUSA has a position on if, and if so, how, online learning should be incorporated at Flinders.

As demand for higher education continues to increase from people from diverse backgrounds, disadvantaged backgrounds, and particularly mature age students, those having to work while studying, those living great distances form university or who struggle to physically attend university, the need for flexibility continues to increase. It is not the case anymore, as it may have been decades ago when higher education was more exclusive and less diverse, that most students can spend the majority of their week on campus. Many students need to work while they study, and have other commitments.

It is also telling that in the 2017 Flinders Exit Survey of students who had left Flinders or were on a leave of absence, the number one change that respondents said would have prevented them from leaving Flinders or beginning a leave of absence was having online study options.

Motion

Student Council supports online learning, such that where possible, practical, and where it would not breach accreditation requirements or detract from the learning experience to do so, individual topics should be made available to be studied both online (externally) and face-to-face (internally), and that courses should be made available to be studied externally, internally, or a combination of both.

Student Council opposes any attempt to shift topics and course available internally to be made accessible solely externally.

7.2 Endorsing the Student Climate Strike – Angus Clarke

Preamble

Tackling climate change is a key question of our time. 2019 began in Australia with mass fish deaths on the Murray-Darling basin, fires in Tasmania, and devastating floods in Townsville. The Australian Government and corporate elite are not doing enough to combat this potentially existential threat.

Across the world, school students have been striking for climate action. Last year, tens of thousands of school students – from Kindergarten to Year 12, defied Scott Morrison's call for "more learning, less activism", and walked out of class for climate justice.

On March 15, school students across Australia will be striking again with the same demands.

7.3 Against the New University Defence Projects – Angus Clarke

Preamble

On February 26 it was announced Flinders University, Adelaide University and the University of South Australia have signed an agreement with French company Naval Group and France's National Centre for Scientific Research to found an international research laboratory in Adelaide. This centre will likely be at Lot 14, the site of the old Royal Adelaide Hospital.

Vice-Chancellor Colin Stirling was, of course, in high spirits about the proposal. This lines up perfectly with his vision of the university; teaching only academics churning through students, while only researchers whose work can be sold to military contractors or big business get to keep researching.

We should stand against the ongoing militarisation of our universities, and oppose this new project.

7.4 FUSA Supports the No Confidence Protest – Angus Clarke

Preamble

The recent university restructure has resulted in over 100 academic staff losing their jobs and a further separation of teaching and research. The university administration has shown that they prioritise profits and university rankings above student and staff well being, as well as the quality of teaching and research. A protest has been called by Say No to Academic Restructures in support of the NTEU call for a vote of no confidence in the university chancellor and vice-chancellor. These cuts have already affected students as courses have been gutted by the staff clear out. In the spirit of solidarity FUSA should promote this protest and send a contingent to it.

We rightly identified in a previous meeting the need for independent student unions. Part of this is steps like establishing our own email server, beyond the eyes of university administration. But a major part needs to be mobilising students in opposition to the anti-staff and anti-student policies of the administration. That's where our power is. At a previous protest at university council, there were over 100 staff and students who went along to demonstrate their opposition to the restructure. It was a mistake that there was such little FUSA representation at the protest, and one those on this council need to rectify if we're going to rebuild student activism and have an independent student union worthy of that title.

Motion

Student Council endorses the March 14th protest and Student Council members will attend as a contingent.

7.5 Jordan Peterson Protest: Report Back and Proposal for Future Protest – Angus Clarke

Preamble

On Monday the 11th of February, far-right academic and his army of incels made an appearance at the Adelaide Entertainment Centre. Around 60 anti-fascist campaigners turned out to defy the normalisation of transphobia, misogyny, homophobia and racism that Jordan Peterson represents. It was a lively event with chanting, costumes and speeches about the importance of unions in fighting against the far-right and everything they represent. As a union which represents students of all identities, racial backgrounds and sexuality, it is of utmost importance to fight against a man who is leading a movement to deny these people rights. That is why it was extremely disappointing to not find another Student Council member in attendance, despite passing a motion to support the rally and promote it. When a far-right figure who has a history of fighting against trans rights, blacklisting academics who he doesn't agree with and promoting sexist ideology, you would hope that the student union would be there in defiance. When we endorse and then fail to attend such a protest, it makes a mockery of our council meetings.

A fantastic open discussion occurred after the protest to plan for future demonstrations against far-right figures when they come to Adelaide. It is important that we build a movement that tells fascists and the far right that if you come to Adelaide you will be opposed and you will lose.

Far-right figures Milo Yiannopoulos, Gavin McInnes, and Tommy Robinson are currently planning a show in Adelaide on the 11th of March. That could change, but there is a plan to protest wherever and whenever they end up showing up. If their March 11 show gets cancelled, there will be a speak out against racism and fascism on the March 11 evening in Rundle Mall.

7.6 Support For the Decriminalisation of Abortion – Angus Clarke

Preamble

Abortion laws in South Australia are woefully inadequate. A 50 year old state law still classifies abortion as a crime. It still requires being carried out in a prescribed hospital, after getting approval from two examining doctors who judge that proceeding with the pregnancy would endanger the physical and/or mental health of the pregnant person, or for reasons of serious foetal abnormality. Abortion can occur no later than 24 weeks into the pregnancy unless in the case of serious foetal abnormality or the pregnant person's health being at serious risk. Doctors can refuse to perform an abortion and a pregnant person must have been a resident in SA for at least two months to access abortion services.

These restriction means that even when an abortion can be accessed there can be serious delays. The Pregnancy Advisory Centre (PAC), in Adelaide's western suburbs, is the only legally prescribed facility in the state that provides abortion consulting full-time. It has a three week wait. There is also a two week wait for abortion appointments at the Flinders Medical Centre

Upper House MP Tammy Franks is currently pushing to reform abortion law. These reforms would remove abortion from the criminal code, remove legal gestation limits for termination and remove the two doctors rule. FUSA should support these changes. Control over reproductive health and access to abortion should be a human right.

The religious right and anti-choice bigots have been organising to oppose this bill. We need to be prepared to protest against them. Appallingly, their views have been echoed in parliament. Liberal Attorney-General Vickie Chapman has said she supports some abortion reform, but that the Tammy Franks bill removes too many restrictions. Disgracefully, Labor party Upper House MP Clare Scriven has also joined the attacks.

FUSA should oppose these attacks and join the call for abortion with apologies.

Motion

Student Council supports free and accessible abortion on demand.

Preamble

While the weather is good and there aren't as many events on campus I thought it would be good to hold a film festival with an environmental theme. I plan to book out the super screen and have free popcorn. The event will likely be held in week 4 or 5 depending on other events and availability of the super screen, but I will talk to the events team.

Motion

Student Council approve \$500 from the environment officer's budget to be spent on movie rights and popcorn for the upcoming enviro film festival.

7.8 Reducing Plastic at Student Council Meetings – Grace Hensel

Preamble

Plastic, particularly single use plastic, is incredibly bad for the environment and a huge amount of it ends up polluting our oceans. Student Council should make a commitment to reducing plastic at our meetings in order to be more environmentally friendly. We should avoid using plastic plates, cutlery and cups – especially since we have normal plates etc available to us at FUSA. It is a bit more effort to have to wash them up afterwards but if we all chip in it won't take too much to do it.

Motion

Student Council commits to avoid using plastic at its monthly meetings. All council members will help with cleaning up afterwards.

8.5 Academic Restructure. Vote of No Confidence in the Chancellor and Vice-Chancellor – Angus Clarke

Preamble: The following motion has been moved by the NTEU in support of the campaign against the academic restructuring at Flinders University:

Flinders University is a public university entrusted to deliver excellence in research and teaching for the public good. Staff, students, alumni, and concerned community members move a motion of NO CONFIDENCE in the Vice-Chancellor and Chancellor to deliver ethical governance, empowering leadership, or due diligence on the academic restructure for the public good. The damage to campus culture and morale could become irreparable unless immediate steps are taken to return to a collegial model of governance. The ill-conceived academic restructure risks the quality of research, teaching,

and community engagement and exposes Flinders to massive reputational damage. Management's gross incompetence to date gives us no confidence in its capacity to effect change that is sustainable, consultative, evidence-based, or in the long-term interests of the university or the broader community.

Discussion:

Conversation was had by Nathan Fiedler (General Council Member) and Jesse Stevens (Education Officer) about the extremity of the motion of no confidence and how it relates to motion 8.9. Jesse Stevens (Education Officer) suggested clarification of the motion.

8.15 Save Hakeem! – Josh Rayner

Preamble: Over the past two months, Hakeem Al-Araibi has been detained at Bangkok Airport, placed in Suan Plu (Bangkok) Immigration Detention Centre and is now facing deportation back to Bahrain, the country from which he sought refuge and where he fears torture and persecution. Hakeem had travelled to Thailand with his wife for their honeymoon before being detained on the basis on an Interpol Red Notice in relation to political charges issued against him in Bahrain. Hakeem had fled Bahrain because of persecution and torture due to his brother's peaceful involvement in protests against the ruling family during the Arab Spring of 2011. Hakeem had arrived in Australia in 2014 and was granted refugee status and permanent residency and has since been playing professional football for Pascoe Vale Football Club in the National Premium League in Victoria. While his footballing status has allowed for some public spotlight to be shone on this story, Hakeem still faces the very real threat of being deported back to Bahrain, with minimal mainstream news coverage of this event to empower public pressure on the Federal Government to become more involved in the fight to bring Hakeem back to Melbourne.

Discussion:

General Secretary (Josh Rayner) spoke on why he felt it important to pass this motion despite this not being directly relevant to students at Flinders University.

8.6 Freedom of Speech on Campus – Angus Clarke

Preamble: During the 2018 NUS National Conference, a "freedom of speech on campus" charter was voted on. FUSA should ratify this charter.

- a) FUSA upholds freedom of speech & expression on campus as an important right for students, staff, and members of the public.
- b) FUSA opposes attempts by university administrations and government ministers or departments to crack down upon freedom of speech on campus, whether it comes in the form of:
 - i. Disciplining academics for publishing their opinions in a personal or academic context
 - ii. Discipline against those engaged in protests, including academic discipline, legal discipline, and university-imposed fines
 - iii. Discipline on the basis of content of student publications.
- c) Protesting is a key form of freedom of expression.
 - i. Protesting outside of a speaking event in order to put across an alternative view is not an assault upon freedom of speech. It is the use of freedom of expression to put across an alternate opinion.

 d) Laws or rulings which compel protestors to pay fines or security costs for demonstrations are an assault upon freedom of expression. They prohibit the most accessible form of freedom of expression to those who cannot pay, and in effect make the act of protesting a punishable
 tion: Student Council ratifies the charter (EDU 4.20). Fighting for free speech, passed at the 2018.

Motion: Student Council ratifies the charter (EDU 4.30 – Fighting for free speech) passed at the 2018 NUS National Conference.

8.7 Hands Off Our Unions and Services! – Jesse Stevens

Preamble: In December, the Liberal senator James McGrath announced he intends to introduce a private member's bill to abolish the student services and amenities fee (SSAF). SSAF funds student unions around the country, in addition to a range of other important services that improve student well-being including but not limited to counselling services, financial support, sporting programs and transition activities

This is yet another attack on higher education, student well-being, student representation and unionism, and the services and programs that so many students rely on. We should oppose any bill that will leave students worse off.

Motion: Student Council opposes any attempt to reduce or abolish SSAF, and affirms its commitment to universal student unionism.

8.8 Solidarity with Staff – Jesse Stevens

Preamble: The academic restructure is well underway. Many staff have taken voluntary redundancies and interviews for the remaining positions are due to be complete by the end of January. The restructure will see a frightening number of experienced academic staff leave Flinders, many of whom have been at the uni for two or three decades. The lack of respect and appreciation with which these staff have been treated by uni management has been appalling. The staff who remain will also be affected by this process for a long time, and working conditions will not be easy in the next 12 months. **Motion:** Student Council stands in solidarity with Flinders academic staff to students, the university and the greater community.

8.9 Student Voice Pilot Project – Jesse Stevens

Preamble: Students as Partners (SAP) is the term given for an approach to university decision-making that involves students working collaboratively with university staff to develop initiatives and make decisions. This is in contrast to university staff/management engaging in basic consultation with students, or informing students once decisions have already been made. SAP in Australia is in its infancy, with Sally Varnham from the University of Technology Sydney developing a national framework for how to expand and implement the approach into universities around Australia. Her work has led to the development of a national 12 month pilot project involving 10 institutions around Australia, including Flinders. This pilot involves both staff and students, and is important for the success of any established SAP framework. This pilot presents as an opportunity to advance student voice, and it would be imprudent of us to not participate in an opportunity to advance student voice. **Motion:** Student Council endorses the FUSA Student President and Education Officer to be involved with the national 'Students as Partners' student voice pilot.

8.10 Pride Fest! 2019 – Sean Henschke

Preamble: Pride fest 2018 was an amazing success engaging over 1,000 students over a week of inclusive events celebrating diversity of sex, sexuality, gender identity and gender expression. Pride fest 2019 aims to be bigger and better and to truly establish itself as an annual event. These events will feature an array of off campus pride fest events continuing with friends of the community and the Queer society in the following week.

Motion: Student Council approves the campaign proposal (see Appendix 7) for Pride Fest! 2019.

8.11 Stop the Torture – Sean Henschke

Preamble: The torture and killing of LGBTIQ people have continued into 2019 with evidence that "Chechen authorities began to abduct members of the LGBT community, bringing them to a government facility. As we were ringing in the New Year with our friends and family, they were being tortured as part of a "preventive mopping up" of people deemed undesirable" as the mass killing of anyone LGBTIQ identifying in Chechnya continues.

Motion: Student Council will share the Amnesty Petition on our Facebook Page; <u>https://action.amnesty.org.au/act-now/stop-crackdown-lgbti-people-chechnya</u>

8.12 We Should be Welcoming LGBTIQ Asylum Seekers – Sean Henschke

Preamble: The Australian Government has been reported to be asking incredibly inappropriate questions about their sex lives to verify a gay couple's claim who were seeking protection in Australia.<u>https://www.buzzfeed.com/hannahryan/two-men-seeking-australias-protection-from-lgbt-persecution</u> (*Linked due to explicit content*) This is continued evidence of poor treatment of those who seek asylum and protection in Australia due to their LGBTIQ+ status with over 70 countries criminalising most LGBTIQ acts and many more without protections for the community there are a large portion of LGBTIQ community within the millions of refugees seeking asylum.

Motion: Student Council condemns the discrimination against persecuted LGBTIQ people. Student Council also condemns the mistreatment of all refugees and offshore processing by the Australian Government.

8.13 Your Faith is Not an Excuse to Discriminate Against the LGBTIQ Community – Sean Henschke

Preamble: Following the Ruddoch Review into Religious Freedom, the freedom for religious groups to discriminate against LGBTIQ people without legal consequences was justified by conservative politicians, particularly over religious schools wanting the right to discriminate by possibly firing or changing staff's roles and expelling students based on identity. This is an issue that affects a large amount of vulnerable young LGBTIQ people and affects their chances of making it to university - not only do they have to combat the challenges of school but institutionalised homophobia and transphobia as well. This also affects students studying in education who want to teach future generations following their university degree. To ensure that these people are protected, Equality Australia have released a petition calling on both major parties to protect LGBTIQ students and teachers.

Preamble: Broadening our scope and branding as a Student Association has been a consistent goal of Student Council over the past few years. FUSA currently has an Instagram page, however, Student Council does not have their own independent site running in similar fashion to the FUSA and FUSA Student Council Facebook pages. It's about time Student Council created their own Instagram page to promote the sublime initiatives, campaigns, and events that are consistently run by Student Council. **Motion:** Student Council endorses the FUSA Student President and General Secretary to create and moderate the content of the Student Council Instagram page in conjunction with the Student Council Facebook Page.

8.16 BBQs for ALL – Jawahir Baraki

Preamble: When I was in my first year at Flinders in 2016, I passed by a FUSA BBQ. I waited in line with everyone else, and when I made the front of the line, I asked if it was Halal, to which I was told no. As a result, I never attended a BBQ again. Late last year an Officer bearer told me the supplies for BBQ's were provided by ALERE, which is halal. When I passed by the next BBQ, I asked before waiting in line if what I'd heard was true, but the casual workers didn't know and spent 15 mins trying to call people to work it out. Once they found out it was Halal, I had to get to the back of the line and wait my turn for my sausage.

To prevent any confusion in future and to promote inclusion, I'd like the causal workers from now on to be informed of whether the meat is Halal or not, so that they are equipped to answer questions quickly. I'd also like for all FUSA Facebook events to include in their event description when the meat is halal. Finally, I'd like for there to be an A4 sized page with Halal written on it either on the food bench or stuck to the edge of it at the BBQ's. As there are many Muslim students at Flinders, it's important that they feel included in the activities we hold as an association and that we never leave people out like how I felt back in 2016.

Motion: Student council agrees to promote that BBQ's are Halal, in order to promote the inclusion of all students with our events.

8.17 International Women's Day – Jawahir Baraki

Preamble: International Women's Day (March 8th) is a day celebrated internationally to celebrate women, their achievements and how far they've come together. Annually, events are held on campus in honour of this date and generally FUSA takes part in these events. This year, the theme is 'Balance For Better'. The theme acknowledges how the presence of women has enhanced workplaces. In honour of this year's theme and in conjunction with the Anti-Racism campaign FUSA is already holding in this week, I'd like to hold a movie screening of the movie 'Hidden Figures' on the super screen in the plaza with free pizza, to celebrate and acknowledge the achievements of women of colour in

While they are informative there are few practical tools that can be used by students in crisis, distress or severe illness. One way to combat this would be to create a webpage on the FUSA website that has accessible resources such as email templates to help students negotiate their learning needs with tutors, email templates for sick certificates and access plans and a flowchart helping students understand the various resources available to them on campus. This could be incorporated under the student support menu. We can use this presentation of information to further link to the existing Flinders channels. This development can be created in negotiation with Flinders Health Counselling and Disability Services to ensure accuracy.

Motion: Student Council supports the plan to create a FUSA disabilities webpage hub to simplify and condense the amount of information available to students while also providing email templates and basic resources to assist students.

8.21 Physical Disability Resources Map – Nicole Cutufia

Preamble: The university already has a myriad of health services along with FUSA's additional resources. At the moment, the process that students should follow when they are in need of assistance is difficult and a new visual graphic that can be published around the university physically as well as digitally published online would help students who are hesitant to access help understand what services are available in one easy image.

Motion: Student Council endorses the creation and publication of a simplified resource highlighting the support services available on campus. Physical printing costs may be used to provide physical copies at the FUSA desk

8.22 #accessibility #photodescription – Nicole Cutufia

Preamble: Students with vision impairments often use additional software such as voiceover to help them navigate social media. Since these types of software cannot interpret information in image form it is beneficial to add photo descriptions that enable people to understand the image that accompanies the content of a caption.

8.24 Lifeline ASIST Training – Katt Hatzi

Preamble: ASIST is a two-day, interactive workshop run by Lifeline that prepares people to provide suicide life-assisting, first-aid intervention.

- 1. Student Voice Advisory Group meeting (UTS)

Student Assist Activity Report - Prepared by the Team Leader, Student Assist

Casework

This report has been prepared in time for the next Student Council meeting and

reflects advocacy work from 1st to 28th February.

Student Assist opened 37 new student cases in February (up from 35 cases opened in February last year). Most students (22; 60%) were using Student Assist's services for the first time.

Each case opened in Student Assist's case management system involves one or more 'issues', which fall into the broad categories of 'Academic', 'Financial' or 'Welfare'. Any given case will have at least one issue attached to it. In complex cases, a student may have a number of interconnected issues adding a multifactorial dimension to their situations and often requiring multi-pronged approaches for satisfactory outcomes.

Student Assist managed 39 new issues in February (down from 53 issues for the same period in 2018). The majority (83%) were Financial issues, followed by Academic issues (17%). Welfare matters (defined in this instance as those encompassing "Equal Opportunity", "Personal", "Employment" and "Accommodation" concerns) were not represented this month.

A closer investigation of the Financial issues in February shows that enquiries relating to "Emergency Financial Assistance" and "Remission of Fees" were the most common issue (a combined total of 46%), followed by requests for assistance with "Centrelink" matters and "Financial Counselling" (10% each).

In addition to casework, 23 students contacted Student Assist via the generic email address to seek advice this month. Queries relating to academic issues represented 52% of the general email contacts. Among the academic queries, requests for assistance navigating "Complaint" processes, applying for "Remission of Fees" and resolving "Enrolment" matters represented 40% of the total number of emails (13% each).

N.B. (1): Ongoing cases opened in previous months are not counted in the above figures.




- Recruitment for the .8 FTE Project Officer role has been finalised and we hope to have the new staff on deck by the third week of March



O'Week

The O'Week stall days are now over for Semester 1 2019. Comments regarding the site layout are below.

- 108 unique organisations, clubs and departments attended across the three days, including 16 commercial stalls, 13 Flinders departments, 54 FUSA affiliated clubs & associations, 19 Flinders Sport clubs and 6 miscellaneous stalls.
- The site plan appeared to work better than previous years, although more may need to be done to activate the South Plaza.
- There were comparatively fewer issues with stalls this year, however issues arose due to stalls (almost entirely commercial stalls) failing to list the electrical and large equipment they intended to use (such as marquees) within their application.
- As the site map was based on each stalls listed equipment requirements, issues such as last minute changes, complaints between commercial stalls and a tripped circuit occurred.
- Stalls failing to attend on the days they requested continue to be a concern. This was of particular concern on Tuesday when 12 stalls failed to attend. This negatively affects the atmosphere of the event, wastes funding (for tables, tablecloths, etc.), and unfairly prevents other applicants from accessing a stall. Both clubs and departments failed to attend on their registered days.
- As a result of the above, it may be necessary to charge a refundable deposit (based on a daily fee) to all those receiving a "free" stall, to reduce the likelihood of stalls being left vacant.

Other Work

Unfortunately work on O'Week, matters relating to the recent Health & Safety Audit and the investigation of the recently disaffiliated club, have significantly delayed work on club matters and projects. In particular, the review of Pool Funding Applications, the opening of Annual Review applications, ongoing work on the Club &
