# 7. Matters for Decision

#### 7.1 International Students Are Not Cash Cows – Nicholas Loh

#### **Preamble**

On 6 May 2019, Four Corners, Australia's leading investigative journalism programme, reported the misconduct and unethical practices of several Australian universities and their contracted international student recruitment agencies regarding their international recruitment practices. Such practices increase international student numbers, so as to increase revenue for both universities and agencies alike. It has been a few weeks since the report by Four Corners

and this remains an issue of concern by staff of Australian universities, domestic students in Australia, and most certainly: international students studying in Australia.

The unethical practices include:

- 1. universities waiving English language requirements and accepting students without prerequisite qualifications;
- 2. agencies charging a fee in exchange for offer letters, and agencies targeting students who:
  - a. are identified as high-risk students;
  - b. have low English proficiency;
  - c. do not have the financial capability to comfortably sustain living in Australia while studying;
  - d. have previously been refused their student visa. If the report of unethical practices by *Four Corners* stands the test of time, and that the practices have indeed been shown to have occurring for a long time beyond any reasonable doubt, then this is indeed most appalling and disheartening.

#### Motion

FUSA condemns the misconduct and unethical practices by various Australian universities and their contracted international student recruitment agencies.

# 7.2 What the People Want – Gemma Lyons

#### **Preamble**

# 7.9 Proposal for development of new version of FUSA Clubs & Academic Association Regulations – Chris O'Grady

#### **Preamble**

Due to many inconsistencies, ambiguities and formatting issues with the current version of the FUSA Clubs & Academic Association Regulations, it is proposed that FUSA engages in a full re-write of the regulations.

This proposal recommends that a working group be formed between FUSA staff, Student Council and relevant stakeholders, to create a comprehensive document that encompasses all FUSA requirements for Club/Association activities, governance, financial management, work health and safety and general operation. # 7.10 Speak Up for Your Students, Flinders Management! – Jesse Stevens

#### **Preamble**

There has never been a more challenging time to be a university student in Australia.

The HECS-HELP repayment threshold is the lowest since its introduction in 1989, placing significant pressure on students to perform well academically. At the same time, Youth Allowance and Newstart payments are not adequate. Newstart in particular has not been raised in real terms since 1994, and is 30%, or \$355 per fortnight below the poverty line. Cost-of-living pressures, including rental costs supported by an inadequate rental assistance payment, also make it difficult for students to survive purely on governments payments.

The increased accessibility of higher education which, while clearly a positive, has increased competitiveness in the graduate job market, made undergraduate qualifications expected for more jobs, and has saturated some fields with more graduates than available jobs.

It is also becoming increasingly required of students to complete a postgraduate degree to gain employment in their field or to increase their chances of finding employment, meaning an increasing number of students are spending 6+ years of full-time study at university, which is a long time to go without working full-time.

Universities are under-funded, resulting in inadequate academic and welfare support services, making it harder for students, and especially students from disadvantaged backgrounds, to perform well academically while maintaining their health.

All of this means that there has never been more pressure on university students to work while they are studying to survive, while at the same time needing to graduate with good academic results, and a history of substantial extracurricular and employment experience.

Student activists and unionists have been campaigning for years on the issues mentioned above, yet in the face of all of these issues, Flinders University Management and, more broadly, Universities Australia, has remained silent on issues affecting students in recent years, including the inadequate rate of Newstart and the introduction of a HECS-HELP cap. It seems strange that, while universities claim to care about the success and well-being of their students, they do not seem to advocate for the changes that will make the most positive impact on students.

It is time that the Flinders University VC and Management came out and publicly advocated both on behalf of Flinders and through their influence with Universities Australia for changes such as an increase to Newstart and the removal of barriers to accessibility to higher education

#### Motion

The Education Officer and Welfare Officer will co-write a letter to the Vice-Chancellor Colin Stirling asking him and University Management to publicly advocate for changes to government policies that will benefit students, including but not limited to raising Newstart and removing the HECS-HELP cap legislated in 2018.

## 7.11 Ramsay Centre, Never at Flinders – Jesse Stevens

#### **Preamble**

The Ramsay Centre for Western Civilisations has been attempting for years to pay universities to allow the teaching of courses over which the Ramsay Centre wants control. The proposed course is "in favour" of western civilisation, not simply about western civilisation.

The Ramsay Centre board includes notorious figures such as John Howard and Tony Abbott, who have demonstrated over many years an unreserved support of imperialism, no remorse over the effects of western civilisation on indigenous peoples, and who seemingly refuse to acknowledge the failings of western civilisation or critique it in any kind of balanced way.

The Ramsay Centre have notably been in negotiations with the University of Sydney, University of Wollongong (who are planning to offer a Bachelor of Arts (Western Civilisation) in 2020) and the University of Queensland. At UQ, students overwhelmingly voted against the introduction of such a course and the inappropriate influence of an external body on the courses offered at the university. The NTEU have also come out against the proposed course.

The course is clearly not about educating students on the history of western civilisation involving an objecting analysis, but rather is about indoctrinating students to be in favour of western civilisation and all of its practices.

Even the Ramsay Foundation, which is essentially the parent body of the Ramsay Centre and the source of its funding, is considering severing ties with the Ramsay Centre due to its insistence on interfering in academic matters at universities and insistence on paying universities so much money that universities are willing to cop the criticism and take the money in exchange for offering the course.

There is no evidence that Flinders University Management have been in contact with the Ramsay Centre, however it is clear that the Ramsay Centre Board wishes to spread its course as far as possible and could very well at some stage in the future contact other universities including Flinders University.

#### **Motion**

Student Council supports the students and staff of the University of Queensland, University of Wollongong and University of Sydney who oppose the introduction of a course in western civilisation founded due to the Ramsay Centre.

Student Council opposes any external body seeking to influence the nature or content of university courses, especially when such attempted influence is driven by ideological rather than educational reasons.

Student Council explicitly condemns the Ramsay Centre, and proactively opposes Flinders University having any negotiations with the Ramsay Centre.

#### 7.12 Not Our Government – Jesse Stevens

#### **Preamble**

The result of the 2019 election will now see 3 more years of a Liberal-National government and Dan Tehan as Education Minister. Over the past 6 years, this government has repeatedly attacked higher education, students and young people. Examples include but are not limited to: - Placing a cap on HECS-HELP debt, resulting in more students paying up-front for postgraduate study or avoiding postgraduate study altogether - Lowering the HECS-HELP repayment threshold to just over \$45k - Attempting to deregulate university fees - Refusing to raise Newstart - Continuing to fund higher education at one of the lowest rates by GDP in the OECD. - Freezing the demand-driven system regarding Commonwealth Supported Places, in effect resulting in tens of thousands of students missing out on higher education, and providing no alternative. - Cutting funding to the Higher Education Participation and Partnerships Program which since its introduction in 2013 has contributed to increased participation in higher education, especially for disadvantaged young people and groups with traditionally low rates of participation. - Prioritising a review into freedom of speech at university campuses over a review into sexual assault and misconduct at universities.

The LNP have not made many public statements on their intentions for higher education policy going forward. What we know is they will be looking at introducing criteria for performance-based funding, which, while appearing to reward universities who do well, has the real potential to create inequity in the educational quality of universities if universities that do poorly do not receive the necessary funding to improve their performance.

The LNP has given no indication of raising Newstart, increasing higher education funding, or reversing its changes that have reduced accessibility to higher education.

FUSA and the student union movement must be ready to act against further attacks.

#### Motion

Student Council notes with concern the re-election of the Liberal-National Party to government who have consistently attacked higher education, students and young people.

# 7.13 Network of Women Students Australia Annual Conference – Jawahir Baraki

#### **Preamble**

'The Network Of Women Students Australia was established in 1987, and founded on ideals of creating a grassroots, autonomous network concerned with issues that impact women and women students.

Every year, NOWSA hosts a conference in collaboration with the National Union of Students and an Australian University Student Association. The conference provides an opportunity for women identifying students to engage with personal, political, social, and cultural issues that effect women. The environment allows students to share resources, skills and knowledge. Attendees also have the opportunity to work together to develop strategies to improve the experiences of women in Australia.'

This year the NOWSA Conference will be held at Macquarie University, Sydney, from the 22nd to 26th of July. As the Women's Officer, it is very important that I attend the NOWSA Conference in order to: meet other Women's Officers from across the country and get inspired for things to do in semester 2; educate myself further on current women's issues, ultimately enabling me to be a better and more informed Women's Officer; and, further my own professional development.

This year, I'd also like to take a student with me to attend the NOWSA Conference. Students will have to apply via email responding to a predetermined set of questions. The successful applicant will be chosen by a panel, which will consist of the Student Representation and Development Officer, myself and one other person. I am requesting to take another student with me in order to: provide professional development opportunities to the female students of Flinders; help educate another woman on the current issues women face, so that they have the skills to create social change, if they desire; provide another female student the opportunity to make friends and connections with likeminded individuals from across the country; and support students who may be interested in attending but might not be able to afford it.

Furthermore, I am requesting the following be paid for the successful applicant and I: registration fees of the conference, which is \$120 per person; return flights to Sydney, which is \$350 per person; and, travel to and from Macquarie University from the Sydney Airport, which is \$50 per person. Total requested: \$1,040

# 7.15 Adani and the Climate Emergency – Angus Clarke

#### **Preamble**

This climate emergency already threatens life on this planet, with increasing numbers of species facing extinction. Last year's IPCC report showed that not enough is being done to curb the usage of dangerous fossil fuels. Our universities should also take a strong public stand in calling for immediate action. It is therefore appalling that Queensland Premier Annastacia Palaszczuk has announced that the Labor Government there will fast track the .outstanding approvals required for Adani's Carmichael mine in the Galilee Basin. FUSA should join the calls to declare a climate emergency and fight for the core demands of this movement, including no to Adani's Carmichael mine.

#### Motion

FUSA condemns the Queensland Labor Government's moves to fast track approvals for the Adani coal mine.

FUSA recognises that we face a climate emergency and expresses its support for;

- 100% renewable energy by 2030
- · No drilling in the Great Australian Bight
- No to the Adani coal mine
- No new coal, gas or oil extraction

FUSA calls on the Flinders University Council to similarly declare a climate emergency and support for these demands.

FUSA will share the petition calling for the University to declare a climate emergency online.

# 7.16 Solidarity with Sudanese and Algerian Revolutionaries – Angus Clarke

#### **Preamble**

The revolutions in Sudan and Algeria are reaching a critical juncture. Millions have taken part in street protests and strikes over the past few months, bringing down dictators whose rule lasted decades. Yet the demands of the uprisings for real democratic change and social justice are still a long way from being fulfilled, as the military and security apparatus of the old regimes attempts to hold onto political power. For us in Australia, the question of solidarity with our sisters and brothers who are risking everything to fight for peace, freedom, social justice and democracy cannot be an abstract one. Our government has a plan to become the 10th largest arms exporter in the world by targeting sales to repressive regimes in the Middle East and North Africa, and continues to cooperate with dictatorships in the region around 'counter-terrorism' and border controls. And as we know, Sudanese refugees in Australia have been singled out for particularly viscous racism, constructed around lies about 'African gangs'. MENA Solidarity, a British based solidarity with Middle Eastern and North African Trade Unionists organization, is collecting messages of support/greetings and solidarity signatures on a letter of support from international trade unions and MP's. FUSA should join in expressing our solidarity and support.

#### Motion

FUSA expresses our solidarity with the struggle to establish genuine democracy in Sudan and Algeria, and opposition to all forms of military rule.

FUSA opposes Australian military or security co-operation with the old regimes (and other individuals and groups responsible for human rights violations), and opposes our governments supplying them with arms or equipment for repression.

Student Council will take a photo in solidarity with trade unionists in Algeria and Sudan and with the revolution, to upload and send to MENA solidarity.

# 7.17 Education Conference – Angus Clarke

#### **Preamble**

The 2019 NUS Education Conference, or EdCon, is fast approaching. With the re-election of the Coalition, the need for students to organise and fight back is obvious. This is a coal loving, student hating, refugee torturing government that must be opposed. EdCon will be a crucial space for discussing the path forward for the student movement. At Flinders, we have experienced the bitter fruit of anti-student policies, with cuts to funding helping to fuel the hated restructure. ## 7.7 Affiliation with the Council of Australian Postgraduate Associations – Katt Hatzi

**Preamble:** CAPA is the peak representative body for postgraduate students. Adequate and tailored representation for postgraduate students is critical — more than 34% of Flinders students are postgraduates. Flinders University was a founding member of CAPA, but our affiliation lapsed at some point. We re-affiliated in 2017.

CAPA has an impressive record in advocacy for postgraduate students. In response to the AHRC Changing the Course report, a range of recommendations were made to specifically protect postgraduate students, whom the survey showed are particularly vulnerable to sexual violence at university. These recommendations evolved into a joint project with CAPA, the NTEU, the Australian Council of Graduate Research, and Universities Australia into the Principles for Respectful Supervisory Relationships. They also have a close relationship with two other organisations we are affiliated to the National Union of Students (NUS) and the Council of International Students Australia (CISA) having signed the Spring Accord December 2017 and since worked on joint campaigns (Fares Fair and Bury the Bill) with both in 2018.

CAPA runs on a shoestring budget and their affiliation fees are the only thing keeping the organisation afloat. Despite their limited budget in 2018, CAPA still managed to complete this project as well as: three Government inquiry submissions, three consultation interviews with Government departments or commissioned investigations, four new pieces of policy and research, 23 media released which resulted in more than 50 news appearances, and 10 invited conference appearances.

In 2019 CAPA have been particularly vocal around the Federal Election, releasing consistent updates, media releases, and infographics that address the issues of postgraduate students.

It's undeniable that we see incredible benefit from our affiliation with NUS and that national bodies create impact for students that would be otherwise impossible for a single university union to achieve. With such a large proportion of our students being postgraduate, it's our responsibility to ensure that their interests are being advocated for to the same degree as undergraduate students. We receive fee discounts for NUS affiliation, and would do the same with CAPA as we did for our 2018 affiliation costs. The full affiliation fee is \$13,263.46.

Last year we paid a discounted amount of \$4000; our circumstances have not materially changed to warrant a change in this amount.

**Motion:** The Student Council endorse FUSA affiliation to CAPA, and approve the expenditure of \$4000 from the remaining funds in the FUSA Memberships budget line with remaining funds to be deducted from the Postgraduate Support and Activities budget line to cover the affiliation cost.

#### Discussion

Manager, Student Engagement suggested holding off on this decision until the Flinders University Postgraduate Students Association (FUPSA) hold their 2019 AGM to allow for the FUPSA executive to consult with postgraduate students to assist them on deciding on their expenditure for the year, which would include the amount to pay for affiliation to CAPA. Katt Hatzi (Student President), Clara Santilli (General Council Member) and Josh Rayner (General Secretary) outlined the reasons why this spending would not be an issue for FUPSA and why they believe it is important to pay the fees sooner rather than later.

#### 7.6 Clothing Isn't as Simple as You Think – Jesy Murphy

Lots of transgender and gender diverse people come out later in life, because of this they don't have a lot of clothes that they are comfortable wearing. They will have to keep wearing clothes that cause them distress and dysphoria because they can't afford to buy a new wardrobe as soon as they come out.

A simple solution to this, is to have a clothing drive. This is where people can donate clothes that they do not want anymore, once they have been donated transgender and gender diverse people can have these clothes at little to no cost, allowing them to have clothes that they are comfortable in.

If FUSA has a box in the reception area it allows people to donate clothes throughout the year ready for a stall that can be set up during the year.

University of Tasmania, Hobart through the joint efforts of the National Union of Students (NUS), Council of Australian Postgraduate Associations (CAPA) and the Australian Federation of International Students (AFIS) to form a unified voice for all international students.

CISA is not aligned with any political party; this allows them the freedom to openly and freely advance its position on issues for the betterment of all international students. It represents international students at all levels. Its vision is to be recognised as a holistic voice for international students in Australia by the local, national, and international community.

The benefits associated from FUSA's sustained affiliation with CISA, which provides an avenue for international students of Flinders University to be represented, was deemed to outweigh the costs (\$440 per calendar year for CISA Membership: Higher Education; in contrast, CISA membership for VET/TAFE/ELICOS and associate CISA membership both cost \$220) associated with FUSA's continued membership and affiliation with CISA. Thus, as International Students Officer, I hereby express my desire on behalf of the international students of Flinders University that FUSA renew its membership with CISA.

# Casework

This report has been prepared in time for the next Student Council meeting and reflects advocacy work from 1<sup>st</sup> to 31<sup>st</sup> May.

Student Assist opened 83 new student cases in May (up from 58 cases opened in May last year and up from 66 cases opened last month. Most students (68; 82%) were using Student Assist's services for the first time.

It is important to note that these figures do not reflect the ongoing work spent on cases opened before the current reporting period.

Each case opened in Student Assist's case management system involves one or more 'issues', which fall into the broad categories of 'Academic', 'Financial' or 'Welfare'. Any given case will have at least one issue attached to it. In complex cases, a student may have a number of interconnected issues adding a multifactorial dimension to their situations and often requiring multi-pronged approaches for satisfactory outcomes.

Student Assist managed 106 new issues in May (up from 66 issues in April). A total of 50% of the issues (53 issues pertaining to 47 cases) related to academic matters, where 'Placement' matters (15%) and 'Complaint' queries (13%) were the most common issues.

A closer investigation of the Financial issues, also accounting for 50% of the issues (53 issues pertaining to 36 cases) in May shows that enquiries relating to 'Emergency Financial Assistance' (18%), 'Student loans' (11%) and 'Financial Counselling' (8%) were the most represented type of queries.

In addition to casework, 45 students contacted Student Assist via the generic email address to seek advice this month. Queries relating to academic issues represented 73% of the general email contacts. Of these, 45% related to 'Complaints', 18% to 'Placement' matters and 15% to 'Academic Integrity' concerns. Graphs summarising caseload are shown below.








The big focus of mine this month has been on **Student Academic Representation Structures**, **Student Representation**, **Student Voice Pilot work and Students as Partners (SaP) project work**.

### STUDENT ACADEMIC REPRESENTATION STRUCTURES

My work on the SAR structures is moving forward. The topic reps in S&E are coming to the end of their role and we will evaluate their experience to keep the programs moving forward. Semester two looks good for the majority of Colleges to roll out more of their SAR structures and I will keep the SC informed of the progress.

Susan Cilento my new SRDO is now an integral part of my team and has been working hard with me. She will be of particular importance with the SAR structure work as she is experienced from her time in HASS.

#### STUDENT REPRESENTATION:

I am at the start of developing some new initiatives for representation in general. I receive large volumes of requests for help recruiting students for representation and leadership opportunities. As such I have created, with the help of the Media team, a new Student Representation & Leadership page on the FUSA website. It will go live very soon. It will be a place where I can advertise all of the representation and leadership opportunities from across the University and outside.

There are numerous SaP projects that I have been contacted about and invited to work on. This includes some Learning & Teaching week partnership work, partnering with CILT for the Student Led Teaching Awards and will be presenting at Adelaide University in June for the 2019 International Students as Partners Institute (ISaPI) and working with one of the Learning Advisors in BGL to help with SaP knowledge development.

Lastly, I've been working on the Student Voice Pilot with Kate Walsh preparing for the Student Voice Summit coming up in Sydney and the Institutional Workshop Analysis (IWA). The IWA was held on Monday 27<sup>th</sup> May and Kate Walsh ran a great workshop and did a fantastic job on the day. There was a wonderful attendance from both senior staff and students from across the University Colleges and portfolios. The discussions were inspiring. ## **Events Report – Prepared by the Events & Projects Officer**

April and May have been very busy months for the events team. On top of our regular events such as Relax, we have assisted Student Council to organise and run a wide range of events, activities and campaigns across the campuses.

#### University Mental Health Week

We worked closely with Oasis to run two main events, one day at Bedford campus and one day at Sturt. The aim of the week was to de-stigmatise mental health and aim to build community and encourage conversations. Throughout the week there was a range of stallholders, interactive workshops, free food, crafts & activities, acoustic music, succulents, free herbal tea, and more. It is recommended that we continue to run this event during this time of year. The national week falls too close to elections and we should be looking to begin these messages early in the year and then continue to re-iterate them throughout the rest of the year with other events/activities such as the swot-vac and exam campaigns etc.

#### **Enviro Film Fest**

Working with the Environment Officer, we ran a range of free film screenings on campus around environmental issues facing the planet. We also handed out free popcorn at each event. The five films shown were Chasing Ice, Princess Mononoke, Bee Movie, A Plastic Ocean and Rubber Jellyfish.

Unfortunately, during the week, the weather took a turn for the worse and most of the films had to be moved to a backup location in the student hub. The four events held inside didn't manage to gain much traction with less than 15 people over the week. From experience running film events run on campus, we recommend film screenings be limited to the warm months where possible so they can be shown on the Super Screen. If timing is a factor, we recommend running environment themed activations within the hub, such as stalls and markets. Some ideas could be free seedlings and gardening workshops, recycling stations and workshops, bottle collections, zero-waste workshops etc.

#### How to Adult

We worked closely with the Welfare Office and Student Assist to run several days of workshops and activities that encourage students to 'successfully adult'. The fair day included a range of stallholders, free food, a cooking demo, free LinkedIn headshots, hair care tutorials and more. There were also a

range of workshops including the RAA Basic Car Care, Self Defence 101, and a Financial Capability Workshops.

We also collaborated with areas running existing workshops such as Oasis (Mindful Yoga Classes and Meditation) and the Careers team (Job Hacks for your Resume and Professional Resilience & Mindfulness). It is recommended that we aim to grow this event in future years and expand to Sturt campus

as

well.

#### Be a Better Human

FUSA will be once again rolling out its Be a Better Human campaign for 2019 in relation to the Australian Human Rights Commission's report on sexual assault and sexual harassment of university students. The campaign focuses on building awareness around matters of sexual consent, rape culture and bystander behaviour whilst encouraging respectful relationships and self-improvement.

In 2019 we aim to communicate these ideas to the new cohort of students, and to re-iterate these messages to continuing students. FUSA will be managing the roll out of four specific campaign elements, the general BaBH Campaign, Underwear campaign, Tavern campaign and the BaBH Campus Fair.

#### Semester 1 Pub Crawl

Working closely with the Social Activities Officer, we successfully sold 400 pub crawl shirts, and made a profit for Student Council of around \$4000. It was a very successful event on the night, and students were very excited by the Big Duck Energy design of the t-shirt created by Jess in the media team.

# Other Work

We have done a stocktake and organised all the FUSA hoodies and worked with the media and admin teams to push for sales during this core time of year as the weather gets colder. We have also done the same for the BaBH underwear to continue to push and sell these.

We are also working closely with Empire Times to plan an 50<sup>th</sup> B-Day party. We are also assisting with creating an ET art installation that will show previous issues and the overall history of the magazine. This will be placed outside the Flinders Tavern during the first few weeks of Semester 2.

## **Pool Funding**

Round 2 applications have been reviewed, and the results have been sent to all applicants. A total of 52 applications were received, requesting a total of \$64,900.26. In total, 44 applications were fully or partially approved, with \$34,967.61 allocated across these applications.

Following the deadline to access Round 1 Pool Funding, there is currently \$8,523.45 remaining to allocated in rounds 3 and 4. However, this will be topped up with any unused General and Start-Up Funding following the deadline to apply (21st July 2019).

# Club & Academic Association Regulations

A proposal has been submitted to Student Council to form a working group and formally proceed with the development of a new version of the Club & Academic Association Regulations. This is due to a variety of issues with the current version, which is outlined within the proposal. This proposal has been provided for review in the June Student Council meeting.

#### **Annual Review**

The deadline for Annual Review applications has now passed (due the 1<sup>st</sup> of May 2019). Clubs & Associations who have not organised for an extension will have their benefits of affiliation suspended until their Annual Review submission is provided.

A list of the 29 affiliated Clubs & Associations that have not completed Annual Review have been submitted to the General Secretary. Most of these are no longer active and can be safely disaffiliated without disrupting student activities. Clubs that still appear to be active in some capacity have been clearly marked, should Student Council wish to consider options other than disaffiliation for these clubs.

## MakerSpace

The Flinders Library is investigating options of creating a student 'MakerSpace' for creation and production. This is inspired by the University of Wollongong model, which includes a wide variety of production equipment and software for 3D printing, embroidery and sewing, electronics, virtual reality, games development, music, podcasting, design and more.

# 1. Introduction & Background

The FUSA Ball is an annual event that has been in existence since 2013 and has traditionally been ran during the September/October period. The event has always remained a traditional style 'Ball' with various themes throughout the years.

Building upon the success of previous years, the 2019 FUSA Ball will be held on Friday 20<sup>th</sup> of September. The event will once again be held at Hotel Richmond, Rundle Street and will run from 7:30pm to Midnight. The event will cater for approximately 300 - 400 students, with the event theme yet to be determined.

In 2019, we will aim to:

- Create a more focused Marketing and Communications plan

### 2. Components of Event

All tickets sales will occur online through Eventbrite, there will be no cash sales. Ticket pricing will be set at two levels, one price for students and one for non-students:

• Flinders students \$50

Non-Flinders students: \$90

For Flinders students, the tickets will be subsidised, with non-students charged the full cost of the beverage and food packages. From previous years, we anticipate roughly 80% of attendees will be Flinders Students, whilst 20% will be non-Flinders students. The ticket pricing will include a canapé and beverage package and students will have access to a free photobooth, and music by local DJ's. There will be additional inclusions to come as planning progresses.

# 3. Media Team (Marketing & Promotion)

An argument can be made that the event might potentially get more traction if it was more closely aligned to Flinders. Calling it the *'Flinders Ball: Hosted by FUSA'*, could be a possible option. # Proposal for development of new version of FUSA Clubs & Academic Association Regulations

#### Introduction

Due to many inconsistencies, ambiguities and formatting issues with the current version of the FUSA Clubs & Academic Association Regulations, it is proposed that FUSA engages in a full re-write of the regulations.

This proposal recommends that a working group be formed between FUSA staff, Student Council and relevant stakeholders, to create a comprehensive document that encompasses all FUSA requirements for Club/Association activities, governance, financial management, work health and safety and general operation.

### **Background**

In January 2013 Student Council approved the first iteration of the Club Regulations following work between the Student President and General Secretary throughout 2012. This document has formed the basis for several revisions following implementation, leading up to the present day. While the current version retains many of the foundations of the original document, the Clubs & Associations program has expanded and evolved to the point where the current document has failed to address many issues relating to the current program.

In practice, many Clubs & Associations find themselves confused with regards to their obligations within this document. Many of the regulations within this document are vague and subject to wide interpretation; while other regulations directly contradict each other. Both Student Council, the Clubs & Events Officer and Clubs & Associations alike have frequently found themselves unsure of the meaning and application of particular rules; often requiring those involved to make assumptions about the intent of the original authors.

The confusion associated with this document is further exacerbated by the formatting of the 22-page document. For example, Clubs & Associations would only know that they must remain not-for-profit by checking the section of the document regarding constitutional requirements. As the regulations are not ordered in a practical way, it is unlikely that Clubs & Associations are ever fully aware of their requirements as an affiliate.

Contradictory clauses within the Regulations have occasionally led to complaints and arguments, such as the claim put forward by the *Gentleman's Club* that they are permitted to have "selective membership" under regulation 4.2, despite this rule being almost immediately contradicted under 4.4 (requiring that no membership criteria other than payment of fees may be permitted). In other cases the Regulations do not fully reflect how the affiliation works in practice, such as the *Criminology Association*'s attempts to become an Academic Association immediately (where usually the club would establish itself and then discuss this with the Student Representation & Development Officer).

In practice, several of the Regulations are simply unenforceable, particularly in relation to Registration. Within the Regulations it states that all clubs operating within Flinders University must be registered; however many student groups would not know that they would even be considered a 'club' and fewer would even be aware of these requirements.

While the Regulations weren't a cause for significant concern in the infancy of the Club & Associations program, the growth of the program has naturally resulted in increased legal,

financial and reputational risk to the University. These risks can no longer be appropriately addressed due to both the inherent flaws of the current Regulations.

# **Proposal Outline**

In consideration of the various issues associated with the existing document, it is proposed that the existing document be rewritten in its entirety with input from all stakeholders to ensure a comprehensive set of regulations that are both easy to understand and follow.

This proposal seeks to establish a working group consisting of the various stakeholders associated with Club/Association activities, including (but not limited to):

- Members from the Clubs & Associations community
- FUSA Student Council
- FUSA Clubs & Events Officer
- Flinders Governance, Legal and Risk
- Flinders Finance
- Flinders Work Health & Safety
- FUSA Student Representation & Development Officer
- Manager, Student Engagement

# **Proposal Costs**

There are no costs currently expected with the proposed project; however due to the scale of this project there is the possibility that other projects may fall behind. FUSA should be aware that it may be required to hire additional casuals and/or temporarily increase hours of currently employed staff to cover other tasks as required.

#### **Benefits**

The benefits associated with this project are outlined below.

- A reformatted document with a logical structure (e.g. categories, order, etc.) would allow Clubs & Associations to quickly and easily understand their obligations.
- Providing all FUSA requirements (such as Finance guidelines, etc.) within one document would reduce confusion regarding obligations.
- Ensure adherence to WH&S expectations.
- Closing loopholes and removing inconsistencies within the Regulations would reduce the likelihood of complaints relating to rejected affiliation applications, cancelled events, disciplinary action, etc.
- A comprehensive document that is easy to understand would likely result in greater adherence to the Regulations.
- Overall, this is likely to see a reduction in legal, financial and reputational risk to both Flinders University and FUSA.

## **Risks**

As this project aims to replace the flawed set of current regulations, there are few risks associated with the project that are not already present in the current iteration.

 Regulations that are not comprehensive in nature may provide Clubs & Associations the opportunity to act within the Regulations while exposing Flinders University (and by extension, FUSA) to legal, financial and/or reputation risk.

- Regulations that are too extensive may become cumbersome for Clubs & Associations to abide by effectively. This may lead to discontent, confusing or ignorance of the Regulations.
- There is likely to be confusion during the transition between the previous Regulations and the new Regulations.

#### **Implementation**

The proposed method of implementing this project is as follows:

- 1. Clubs & Events Officer to create the structure of the document to use as the foundations for the new regulations.
- 2. Student Council to select members to become involved in a workgroup (preferably those with experience in managing Clubs/Associations) to create new Regulations, in collaboration with Clubs & Events Officer and relevant stakeholders.
- 3. Representatives from WHS, Flinders Legal, Flinders Finance, Clubs/Associations and other stakeholders as required to be invited to contribute in workgroup meetings.
- 4. Workgroup to meet regularly (preferably weekly) to make recommendations/revisions for Regulations. Clubs & Events Officer will take recommendations/revisions and work into the existing draft for further review.
- 5. Following completion of the draft by the workgroup, draft to be distributed to relevant Flinders stakeholders for approval, to ensure Health & Safety, Legal, Finance and other relevant concerns are addressed within document. Workgroup to address any concerns raised through revisions to document.
- 6. Following revisions from Flinders stakeholders, draft to be distributed to Clubs & Associations for further feedback.
- 7. Student Council to formally review and approve Regulations, providing a short grace period to allow for any confusion caused during the transition period.

## **Approval**

Approval is sought by Student Council to establish a working group and proceed with work on this project.
